

CONTIN-TAIL  
AUGUST 10-13, 2006  
RULES AND REGULATIONS

1. A pre-registration fee is required for all participants who register prior to June 30, 2006. The fee will cover payment to the city of Buena Vista for a vendor permit and a small amount to CFGMS for expenses incurred in promoting the show. No fees will be accepted by mail after June 30, 2006 All non-registered vendors will pay at the time of registration and will be assigned a space as they are registered.

2. Absolutely no sales will be permitted outside the vendor area.

3. No fees will be charged to non-vendors who camp outside the vendor area.

4. A portion of the pre-registration fee will be refunded if cancellations are made prior to July 15, 2006. Refunds after this date will be determined on a case by case basis.

5. **Pre-registered space fees are \$50.00 each. Fees after June 30 will be \$60.00 ea. Vendors sharing a space with another vendor must pay an additional \$12.00 for each additional vendor to cover the City's vendor permit.** This is a vendor fee and not part of the space fee. Any individual selling at Contin-tail without a permit will be asked to leave the premises and will not be allowed to return. Any registered vendor allowing a non-registered vendor to sell from his space will also be asked to leave and will not be allowed to return. Vendors sharing space with another vendor must have the approval of the show committee and must list that vendor's name on their contract.

6. Spaces may not be subleased. Contact the Contin-tail Committee directly if you are going to be unable to attend and use your space. Do not tell anyone else that they can have your space.

7. **All vendors must sign in at the registration desk upon arrival to obtain their space location.** No dealer will be allowed to occupy his space until he has registered. The Registration Tent is open from 8:00 a.m. to 7:00 p.m. Park outside the vendor area if you arrive after these hours.

8. No vendor will be allowed to move to an unoccupied space belonging to a vendor who has pre-registered. If the show committee deems it necessary to fill this location to maintain continuity of spacing they will reassign the space appropriately.

9. Vendors will be given two badges per space which must be worn at all times. Additional badges may be purchased for \$1.00 each.

10. If the City distributes vendor permits, they must be displayed prominently at all times.

11. The spaces will be 25 ft north and south and 45 ft east and west. ***All vendors with RV's or trailers will be required to park in an east-west direction.*** Any vendor with an oversized rig or more vehicles than will fit within the boundaries of a regular space will be allocated a space in the farthest west row or will be required to park his rig elsewhere. **Rigs may not extend out of their space into a walkway or driveway.** The vendor area is for vendor parking only. Friends and family should park excess vehicles to the west of the vendor area.

12. Any person selling at the Contin-tail is responsible to collect sales tax for the State of Colorado and the City of Buena Vista and to remit the same to the Colorado Department of Revenue, 1375 Sherman St, Denver, CO 80261-0013 no later than the 20th day of the following month of the show. Forms can be downloaded from [www.taxcolorado.com](http://www.taxcolorado.com). This is an individual responsibility and is not monitored by CFGMS. Direct all your questions concerning the payment of taxes and the purchasing of licenses to the State of Colorado (303—238-7378), not the Contin-tail committee.

13. The Contin-tail is a rock, mineral, fossil and related items show. It is not a flea market. Ninety percent (90%) of material sold by a vendor must be related to the Lapidary Arts and Earth Sciences. Absolutely no weapons of any nature will be permitted to be sold at Contin-tail. Vendors will not be allowed to sell food items (including soft drinks, water, etc.).

14. Parking in fire lanes is not permitted. All fire lanes are marked by flags or signs.

15. Generators must be turned off no later than 10:30 p.m.

16. Pet owners are responsible for their animals including cleaning up any messes they make. All pets must be kept on a leash at all times while on the premises.

17. Anyone engaged in behavior deemed unsafe or attempting to interfere with the orderly operation of the Contin-tail will be asked to leave.

18. All vendors and campers are responsible for policing and removing trash from their areas. A trash receptacle is furnished by CFGMS for this purpose. Any vendor leaving trash or excess rock in their space at the close of the Contin-Tail will not be allowed to return. This includes rock brought in from the edges of the field for weight. Return it to where you got it! If we have to move it, you won't be back!

19. The show committee will remain in place until 10:00 a.m., Monday, August 14, to ensure the above rule is adhered to.

20. The show committee and executive committee of CFGMS has final say in all matters. We reserve the right to disallow space to any vendor.

Pre-registered, returning vendors and long-time attendees will be given priority consideration when assigning spots. Vendors who paid for their space and who gave proper notification that they were not going to be able to attend the event have priority over those who were placed in their spaces the previous year. Please note the location you were in last year and any preferences you have as to neighbors. If requested, we try to place vendors in close proximity to friends. We cannot always do this because of prior space allocations but we will consider your requests. This contract does not guarantee any vendor a specific location.

Only dealers who have sent their contracts in to the treasurer and have paid their fees by the deadline are considered pre-registered. Please do not give money directly to the show committee and expect them to be able to hold a pre-registered space. **There is no verbal pre-registration.** Pre-registration is encouraged and appreciated. It is the only way we can assign spaces and guarantee continuity throughout the show.
